Update on COVID-19 From the Town of Needham and Needham Public Health

April 8, 2020 – The Town of Needham and Needham Public Health today provided the following update regarding COVID-19.

State DPH COVID-19 Numbers

The Massachusetts Department of Public Health is reporting that as of April 8, 2020 there are:

- 16,790 cases statewide
- 1,778 Norfolk County
- 433 deaths statewide
- *Note: This is not new information. As of April 7, 2020: Needham has had a total of 61 confirmed cases of COVID-19, and 31 community members have recovered from the virus. Two public safety employees have had confirmed cases. Those two employees are recovered. Town data is updated Tuesdays at 5 pm.

Voting Options for Social Distancing

The Annual Town Election scheduled for Tuesday, April 14, 2020 has been rescheduled to May 26, 2020. Those who need to register to vote have until 8:00 p.m. Friday, May 15, 2020 to do so.

To continue efforts to social distance, a new law provides for two alternatives to voting in person:

- First, the law allows any person taking precaution related to COVID-19 to vote by **absentee ballot** by reason of physical disability. All applications for an absentee ballot must be received by the Town Clerk before noon on **Monday May 25, 2020**, the last business day before the election. Any person may apply for an absentee ballot by sending a signed request to the Town Clerk's office or filling out the absentee ballot application available here. The ballot must be received by the Town Clerk before the polls close 8:00 PM on Election Day (May 26, 2020)
- Second, the law provides for early voting by mail. All applications for early voting ballots must be received before noon on Monday May 25, 2020, the last business day before the election. Any person may obtain an early voting ballot by sending a signed request to the Town Clerk's office or by filling out and returning the early voting application available here. The early voting ballot must be received by the Town Clerk before the polls close 8:00 PM on Election Day (May 26, 2020).
