The meeting convened at 7:35 PM in the Selectmen's Meeting Chambers located in Needham Town Hall.

#### **Project Presentation:**

FY2012-02: Charles River Center – South Street Home: Ms. Young introduced John Grugan and Maria McTernan from the Charles River Center (CRC). Mr. Grugan and Ms. McTernan gave a brief background on the CRC and presented their proposed South Street project, providing additional detailed timeline information and their annual Report of Giving to each of the Committee members. [See Addendums 1.a and 1.b] The timeline Mr. Grugan provided answered several questions on the status of the CRC Wayland building project while the Report of Giving that Ms. McTernan reviewed gave the Committee actual numbers to compare upcoming fundraising efforts to. They also provided each Committee member a copy of the letter the CRC had recently mailed out to the South Street properties neighbors, inviting them to an information session regarding their long term goals for the property and to answer their questions. [See Addendum 1.c] After this meeting, the Committee's questions about public outreach and neighbor opinions would also have answers.

After a recommendation that photos or drawings from both the Wayland and Needham homes be included as part of the CRC presentation at the March 21<sup>st</sup> Public Hearing, the South Street Home project presentation was complete until the final review at the Public Hearing.

#### Review and Acceptance of Minutes of Meetings:

Ms. Bernardo made a motion to approve the minutes of the February 1, 2012 meeting. The motion was seconded by Mr. Retzky and was approved unanimously.

Mr. Retzky made a motion to approve the minutes of the February 8, 2012 meeting. The motion was seconded by Ms. Bernardo and was approved unanimously.

#### **Chairman Updates:**

**Town Hall Nominations:** The Historical Commission has nominated the Town Hall project for a preservation award. Mr. Gluesing has submitted a letter of support. (See attached, Addendum 2)

**Jane Howard Recognition:** Mr. Gluesing took a moment to say a few words about Jane Howard in reflection of her recent passing.

"Committee member Jane Howard died earlier this month. I want to take a moment to recognize Jane's service to the Community Preservation Committee (CPC). She was appointed to the CPC by the Board of Selectmen in 2007. She was a valuable contributor to the Committee. While serving as a project liaison on the CPC's largest and most controversial project, the renovations to Needham Town Hall, she provide thorough and diligent review of the project for the Committee, and after it was funded by a vote of Town Meeting, she provided continuing oversight of the project on behalf of the CPC. Jane served as Committee Chair for two years. She led the Committee with a keen attention to detail and efficiency. She improved the Committee review process and the timeliness of feedback with project applicants. She implemented an improved schedule of review and coordination with the Board of Selectmen and the Finance Committee that enabled those boards to more easily contribute to the deliberations of the projects. She was a valuable ongoing resource to the Committee after her Chairmanship. The Community Preservation Committee was but one of the many civic and social groups that received the generous donations of Jane's time and energy. She was a valued colleague and friend. The Town of Needham has benefited from her public services, and she will be very missed."

<u>Preparation for Public Hearing and Town Meeting</u>: Mr. Gluesing informed the Committee that Town Counsel had requested that he and Ms. Boulris remain completely uninvolved in the process of the Historical Preservation presentations during the Public Hearing, and exit the room during each presentation due to his and Ms. Boulris' roles as sitting members of the Historical Societies board.

Mr. Gluesing and Ms. Bernardo reviewed the CPC Public Hearing process and wanted to remind everyone that if there was a large crowd of residents during the Public Hearing, that they would request the presenters take more time to thoroughly review their project and all of the Committee questions to date. However, if only the Committee and other presenters were in attendance, that presentations are kept brief and Committee questions become the focus of the hearing.

Mr. Gluesing also decided that there would not be any votes made following the Public Hearing on March 14<sup>th</sup>, and that all decisions regarding FY-2012 projects will be made at the meeting scheduled on March 21<sup>st</sup>.

Adjournment: Mr. Retzky made a motion to adjourn the meeting at 8:30 PM. Ms. Bernardo seconded the motion. The motion was unanimously approved and the meeting was adjourned at 8:30 PM.



### Wings for Autism Soar

ravel for anyone can be exhausting but for families of children with autism, travel can be daunting. A busy airport with numerous sensory inputs—from noises and smells to public announcements and movement— can be overwhelming and extremely difficult for children on the autism spectrum.



Inspired by the Littlejohn family, The Charles River Center partnered with JetBlue, Massport and Transportation Security Administration (TSA) and opened the doors to hundreds of families who desperately want to travel. On two separate occasions at Logan Airport Terminal E, families with a child or young adult with autism had an opportunity to take a "practice run" getting boarding passes, going through security, and actually boarding a plane in hopes that travel, someday, would be possible. Parents, grandparents, siblings and teachers all came along to help establish travel routines that are key for many children with autism who cling to structure and repetition.

More than 40 pilots, flight attendants and airport personnel from JetBlue as well as corporate staff from Massport and TSA volunteered their time each Saturday. They learned about some of the behaviors associated with autism, were gracious to families and most importantly, eased their stress so that their children would become more comfortable with the whole process.




In addition to the actual "practice run," the Wings for Autism Boston team designed unique lapel pins for families to wear so that airport and airline personnel will be alerted to the potential needs of a family and can offer assistance.

Charles River and the entire Wings for Autism Team are excited about this partnership going forward. Children cited California, Germany, Chicago and even Aruba as their preferred destinations. Whatever the preference, it was gratifying to see that taking a trip could now become a reality for many families.







### Natick Site New Home to Family Support Center and Opportunities and Visions

he Charles River Center opened a 6,000 square-foot office in Natick to better serve its families and individuals who live in the MetroWest area. Charles River's Employment and Family Support divisions share this new site.

#### **MetroWest Family Support Center**

Recognizing that it is often difficult to find appropriate programs and resources, the staff at this new Support Center is providing families with information, referrals, parent trainings, and networking opportunities to help them access community resources for their children and young adults with intellectual disabilities and autism spectrum disorders.

Charles River understands the enormous strain that is often placed on a family caring for a loved one with a disability. In order to provide increased opportunities for respite, Family Support held several Parents' Afternoons Out, giving families a break while their children participated in fun, recreational activities.

In collaboration with Impact Boston, Charles River also offered an eight-week course on safety training for young women (ages 14-18). This personal safety training program gave teens with physical, intellectual, visual or other disabilities the skills to respond appropriately to bullying or threatening situations. Teens openly acknowledged their challenges in a positive learning environment.

#### **Opportunities and Visions**

Due to the popularity of its Opportunities and Visions Program, Charles River Employment Services opened a second program here in Natick, matching individuals with employers and volunteer sites in the MetroWest area.

Two new employment sites for Opportunities and Visions Natick participants are Millwood Farms Golf Course in Framingham and VERC Enterprises. This golf course is located on the historic site of Millwood Farms, an award winning dairy farm. On a weekly basis, a crew from Charles River does landscaping and gardening as well as repairing divots and pine brush clean up.

Two individuals are now working at VERC Enterprises, a family owned convenience store/gasoline and car wash group running 23 facilities in Massachusetts and southern New Hampshire. Working closely with the communities it serves, VERC is committed to hiring individuals with intellectual and/or developmental disabilities. Joey is in Weston and Peter is in Marlboro. Both stock shelves in the store, perform general maintenance duties and even pump gas!

Favorite volunteer sites in the MetroWest area continue to be Greyhound Friends, Salvation Army, St. Vincent de Paul, Meals on Wheels and Lincoln Sudbury High School.


Dedham Institution for Savings Foundation and The Wellesley Hills Junior Women's Club for continuous financial support of many capital projects as well as program initiatives.

Charles River Association for Retarded Citizens, Inc. (d.b.a. The Charles River Center), has purchased the property located at 1285 South Street in Needham.

We are reaching out to you as nearby neighbors to invite you to an information session about our agency and the plans we have for this property. We plan to hold this session on Thursday, March 22, 2012 at 7:00 pm at our Merritt Building which is located at 59 East Militia Heights Road in Needham.

As you may know, this property has been dormant for some time and the home on the property has deteriorated. We plan to tear this structure down and build a +/- 3,000 sq. foot ranch style home that will serve individuals who have developmental disabilities and need accessible and affordable housing. Most, if not all, need to use wheelchairs for mobility. Therefore, this home will be all on one level with features designed to reduce barriers for the people that will live there. The home will look much like many of the homes in Needham. There will be staff present to provide education and training to the residents and to provide ongoing supervision and care.

Our non-profit organization was founded in Needham and is recognized in the community as a responsive and responsible neighbor. We currently support people with disabilities in nineteen homes and fit seamlessly into our surroundings. We have done this successfully for over forty years, opening our first home in the early 1970's.

We have enclosed a self-addressed post card for you to use to let us know if you would like to attend the information session.

We look forward to the opportunity to meet you and tell you more about us and our plans for the home in more detail.

Needham Town Hall Nomination Massachusetts Historical Commission 2011 Preservation Award Rehabilitation and Restoration Category

Dear Ms. Simon:

In 2009, the Needham Community Preservation Committee recommended that Needham Town Meeting vote to fund preservation of Needham's Town Hall. After an exhaustive analysis of the options for renovations and additions to the building, the Committee was pleased to recommend financing the selected design scheme, which maximized the preservation of the building structure and uses, with a respectful and complimentary addition. The buildings historic fabric was restored with care, and modern amenities and life safety systems carefully and respectfully integrated into the structure.

The Needham Community Preservation Committee strongly supports the nomination of Needham Town Hall for the Massachusetts Historical Commission 2012 Preservation Award. Town Hall is the treasured center of town life in Needham. The preservation of this building has enhanced this position, through restoration of the historic Great Hall. This grand space once again was able to host a special session Needham's Town Meeting last fall, as well as many other civic events. It is a profoundly successful project and a perfect representation of the goals of the Community Preservation Act, and is the largest project funded through that Act to date.

The project was completed at the end of Needham's 300<sup>th</sup> anniversary year, and the Town Hall Gala was the crowning event in a yearlong celebration, attended by hundreds of residents. By day, the restored golden cupola and clock is an anchor to Needham Center, and by night, the Great Hall glows and adds a vibrancy to the town green that did not exist before the renovations. We hope the Historical Commission will recognize the value of this great community achievement and award Needham Town Hall with a 2012 Preservation Award.
