# Hearing: Fast Signs representing Katie Klein Orthodontics to be located at 32 Chestnut Street for a second attached wall sign. – Tim Parker

The Board had previously reviewed and approved the signage presented to them, but when Mr. Parker presented the signs to the Building Department, he was told he needed a special permit for the second wall sign.

The second wall sign would face Chestnut Street and be installed on the right side of the property.

The sign is 14.2 inches high and 92.17 inches wide. The sign has the words "Katie Klein Orthodontics" on it, which are made of non-illuminated ½" white acrylic letters, stud mounted with spacers.

Mr. Chair noted for the Board that when they last reviewed this sign they made two conditions, the first condition is that they adjust the letter spacing in the upper text line, and that one-inch spacers be reduced to a quarter inch. The Chair suggested to re-impose those conditions again.

The Board reviewed the specifics of what they had discussed at the previous meeting when they reviewed the sign.

Motion to approve the special permit sign with the conditions that the letter spacing in the "Katie Klein" line be adjusted, specifically the "K-a-t" section, and that the one-inch silver spacers be reduced to ¼ inch by Mr. Reilly.
