- Survey Results
 - 51 Respondents
 - o 68% White
 - o 90% Women, 30+
 - Community Events: Music
 - Population in need of funds: Low income, Seniors, BIPOC, Children/teens
 - Outreach: Facebook mainly, newspapers as well

- 70% Unaware of our name change
- o 60% would use an online Arts calendar
- 66% Unaware that we grant funds, down from 76% last year

FY21 Council Priorities

- #1 Needham based orgs and individuals
- #2 New submissions, especially those that address the needs of underserved/in need groups
- #3 Applicants that elevate the diverse experiences of historically marginalized populations
- #4 Programs that demonstrate community support or utilize partnerships
- #5 Orgs that are suffering because of the economic impact of COVID

Complaint from Past Grantee

- Reached out to Charly about not receiving grant for FY21, Charly provided resources to appeal the grant denial
- Need to look at priorities to ensure there is a clause clearly states limits to funding by organization or population served

• FY22 Council Priorities

- o Include line in FY22 priorities that mentions spreading funds equitably across groups
- Remove clarification of "New Submissions" to just "submissions that address the needs of underserved/in need groups"
- o Include: Council aims to accommodate a wide range of audiences in Needham
