Mr. Pingitore completed a roll call for all members of the Committee and members of staff and the results of the roll call are noted above. Mr. Pingitore called the meeting to order at 7:03 PM via a Zoom Meeting. Mr. Pingitore reviewed the rules of the meeting that was being conducted remotely and online inline with Governor Baker's order regarding Public Meetings. Mr. Pingitore covered meeting ground rules for the meeting.

Chairman's Updates

Mr. Pingitore shared that as a follow up from the last meeting, the unused allowance used in the Debt Services report does not include the additional 11% that is proposed for this upcoming funding cycle.

<u>Discussion on Vote – review of input from public hearing, Select Board, and Finance Committee</u> FY22-01 – Article 24: Emery Grover Renovation/Addition Project – Option #3 (Rotated) This request is for \$1,475,130 for design funding to design the renovation of the historic Emery Grover building under Historic Preservation. *Liaisons: Mr. Dermody and Dr. Barnes*

Mr. Alpert had no comment. Mr. Barnes still would like a further commitment on secondary funding for the construction. Mr. Dermody shared that he supports the project and would like to save the building but understands that we need to spend CPC funding wisely. Ms. Dorfman asked if the secondary funding is not known before the vote is taken, what happens with the funding for design. Mr. Gerstel had no comment. Ms. Kirk had no comment. Mr. Zimbone stated that he reviewed discussion that Finance Committee had after the overall CPC discussion had occurred. Mr. Zimbone shared that the Finance Committee discussed Emery Grover in terms of where it was on the list of priorities for the School Committee.

Mr. Alpert made a motion to recommend funding on the Department of Public Works and Town Manager's request for \$1,364,000 for the Town Common Historic Redesign and Beautification in the amount of \$1,000,000 under the historic designation which will be transferred from the CPA Free Cash and the balance from non-CPA sources. Mr. Gerstel seconded the motion. Mr. Alpert seconded the motion. Mr. Alpert made a motion to recommend funding on the Department of Public Works' request for \$262,000 for the Town Reservoir Sediment Removal design in the amount of \$175,000 under the open space designation which will be transferred from the CPA Open Space Reserves and the balance from non-CPA sources. Mr. Crocker seconded the motion. FY22-12 – Article 32: Increase Affordable Housing Bucket Contribution

This request is for and increase to the annual contribution to the Community Housing reserve fund from 11% to 22%. *Liaison: Rick Zimbone, Joe Barnes, Robert Dermody, Laura Dorfman*

Mr. Zimbone made a motion to recommend that the annual contribution to the Community Housing Reserve be increased this year from 11% to 22% for this current fiscal year. Ms. Kirk seconded the motion. - A. Administrative and Operating Expenses of the Community Preservation Committee \$82,000
- B. Community Preservation Fund Annual Reserve \$1,225,714
- C. Community Housing Reserve \$764,783
- D. Historic Resources Reserve \$0
- E. Open Space Reserve \$382,391

Financial Warrant Article – Article 34: FY2020 Community Preservation Reserve Funds
This request comes from the Assistant Town Manager/Finance Director to adjust funds previously appropriated to reach the correct level of funding.

Mr. Pingitore made a motion to recommend that pursuant to Massachusetts General Law 44B the sum of \$11,935 be set aside for future appropriation to the Community Housing Reserve and the sum of \$11,935 be set aside for future appropriation to the Open Space Reserve, and that to meet this appropriation that \$23,870 be transferred from CPA Free Cash. Mr. Alpert seconded the motion.
