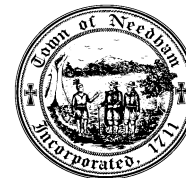

Commercial haulers shall be defined by any of the following:

- Businesses hauling trash or debris as a primary function
- Businesses regularly bringing trash for disposal equivalent to 2,000+ lbs./week or 4,000+lbs./month
- Vehicles with commercial or business markings
- Vehicles with commercial plates disposing of trash other than PAYT yellow bag trash

Operational Requirements:

- All commercial vehicles must permanently affix a Needham sticker to the lower driver-side windshield
- A separate Commercial Sticker Application Form must be completed, and a commercial sticker acquired, for each additional commercial vehicle utilizing the RTS
- All permitted commercial haulers must comply with the Board of Health's *Article 2, Regulations Governing Collection and Disposal of Solid Waste, Recyclables, and Food Waste*
- All loads coming into the Needham RTS must be fully tarped and compliant with MGL Chapter 85, Section 36 *Construction and Loading of Vehicles to Prevent Dropping of Load On Way*
- All debris tipped at the RTS must be compliant with MA DEP's Solid Waste Management Facility Regulations 310 CMR 19.017 *Waste Bans*
- All debris tipped at the RTS must be compliant with MA DEP Hazardous Waste Management Regulations 310 CMR 30.00 (Hazardous Waste)
- All debris tipped at the RTS must be compliant with MA DEP Massachusetts Contingency Plan 310 CMR 40.00 (Hazardous Materials)
- Truck bodies 20' + in length, or dump trucks with 15 cubic yards + capacity may only tip by appointment
- Commercial vehicles must follow designated traffic patterns and must adhere to safe traffic speeds
- Any residual waste dropped on the ground or recycling platforms must be cleaned up by vehicle drivers
- Contractor waste will only be delivered to the RTS T-F, 7:30am to 4:00pm. Contractor waste will **NOT** be accepted on Saturdays. During summer hours, contractor waste delivered to the RTS will be accepted on Saturdays from 7:30am to 12pm

Violations of Operational Requirements will be recorded by RTS staff and discussed with vehicle drivers.

Violations:

- A verbal reminder will be issued by staff for the first violation of Operational Requirements
- A written warning will be issued by staff for the second violation of Operational Requirements
- A 3-day suspension of tipping privileges will result for the third violation of Operational Requirements
- A revocation of all tipping privileges and loss of the use of the commercial sticker for the remainder of the year will result for a fourth violation of Operational Requirements
